- If your state requires a course number, you **MUST** enter it on the *IPCA Verification Form*.
- You must fill out a new form for each state you need recertification credits for.

- All attendees must provide attendance verification by completing the designated sign-in sheet, in addition to, having the IPCA form punched. You must include Course #IPCA20A in the course number box in order to receive credit. This conference has been approved for 2 continuing education units for applicators licensed in the following categories: 7A, 7B, 7D, 8, & 10. The participants must attend the full CIC to receive credit. At the end of the meeting, please see the IPCA monitor at the registration desk to collect a certificate of completion.
